That, on the 5th May ,2023 at 11:30 AM my above said residence “ Owned/Rented” was attacked, destroyed, looted and burned by a group of Meitei /Meiteis radicals.

These criminals broke/open my gate(s) destroyed and looted every valuable property fom my residence and premises worth Rupees 70,5000/- (Approx) and they burnt down all the remainings.

While carrying out their said criminals activities ;the said Meitei radical groups were shouting anti -tribal slogans.

I, therefore, request you to kindly take strong action against the perpetrators by registering an FIR/Zero FIR under relevent sections of Law
