These criminals broke/open my gate(s) destroyed and looted every valuable property fom my residence and premises worth Rupees 5136982/- (Approx) and they burnt down all the remainings.

While carrying out their said criminals activities ;the said Meitei radical groups were shouting anti -tribal slogans.

I, therefore, request you to kindly take strong action against the perpetrators by registering an FIR/Zero FIR under relevant sections of Law
