With due respect, I have the honour to report that, on 28-06-2023 at around 8:00 am, groups of miscreants suspected to be Arambai Tengol, Meitei Leepun and other extremist volunteers numbering more than 500 people by firing various automatic weapons attacked our village i.e Singda Kuki village. Kangchup, Kangpokpi District. In the incident, the miscreants have vandalized my house, looted all my household properties and domestic animals and finally burn down my house along with my Activa bearing No.MN01AC-8732 to ashes.

The approximate value of the loss properties is estimated to be about 65 lakhs (sixty five lakhs) only.

I therefore kindly request you to take necessary action in this regard.
