



Subject: Report.

Sir,

With due respect and humble submission, I beg to state that on 05/05/2023 at around 12:00 PM some unknown miscreants armed youth suspected to be People liberation army. (PLA) united national liberation front (UNLF) Kanglei Yaowon Kanna Lup (KYKL) and prepak cadres assisted by meeitei Youth organization Arambai Tenggol meeitei leepun and kangleipak kanba lup (KKL) numbering about 1000 member carrying sophisticated like AK Rifles, SLR forcefully entered my village Singda Kuki village, P.O. Lamshang, P.S- Gangnom Sapormeina, Saitu Gamphazol Sub-Division, Kangpokpi District, Manipur. After looting all the valuable house hold items and properties my house was burnt down to ashes.

The total worth of the properties lost are as follows :

- (i) Residential house ( Rs. 30,00,000)
- (ii) 3 Bed and 3 Almirah( Rs. 1,50,000)
- (iii) Washing Machine, Fridge, TV, Solar plate (Rs. 1,00,000)
- (iv) Gas Utensils etc(Rs. 50,000)
- (v) Sofa Set(Rs. 80,000)
- (vi) Traditional dress (Khamtang suit)(Rs. 3,00,000)
- (vii) Wood 86 pc 86 cubic (Rs. 70,000)
- (viii) Tata tin 10 Ban (Rs. 80,000)
- (ix) Window frame 7 (Rs. 80,000)
- (x) Goat 7 (Rs. 70,000)
- (xi) Duck and hen 20 (Rs. 20,000)
- (xii) Door frame (Rs.10,000)
- (xiii) Iron rod 6 bundle (Rs. 7,000)
- (xiv) Carpentry materials (Rs. 2,00,000)

The approximate value of lost properties is estimated at about rupees 43,00,000 /- (Rs. Fourty three Lakhs only) and all documents which were priceless were also burnt.

Therefore, I request you to kindly register the case and take necessary action according to law.


