Subject :-Reporting on looting, Vandalism and burning of house, household items assets and documents

Sir/Madam,

With reference to the above cited Subject, I have the honour to report to you as follows:

1. That, I Lunkhohao Tuboi aged about 47 Yrs. S/o Paosei Tuboi belonging to the Kuki Tribe/Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act, 1989, and that I am a permanent resident of K. Phaijol Kangchup Chingkhong (Gannom) P.O./PS Saparmeina, Kangpokpi, Manipur-795146.
2. That, at about 7 pm. on the 4<sup>th</sup> May 2023, a huge contingent of armed radical Meitei/Meeteis suspected to be members of the Arambai Tenggol and Meitei Leepun along with various state forces like Manipur Police Commando and Indian Reserved Battalion (IRB) attacked our Villages and in the process, they have looted, vandalized and torched my house along with all my Original documents.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs10,00,000 (Ten Lakhs) only.
4. Fortunately, me and my family managed to escape from the criminals who even try to kill or burn us alive, and now currently taking refuge at Salemphei village Churachandpur Manipur.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I was at different places to save my life and now I am able to restore my health and settle at Salemphei Village. And, thus I am filing the report lately today.

In the given circumstances, I humbly pray you to kindly register a FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and Obligated.
