Madam.

With reference to the above cited subject, I have the honour to report to you as below :

1. That, I Lalcha Touthang age 23 H/of Tinngaiching DOUNGEL belongs to the Kuki Community, a Schedule Tribe recognized the Constitution of India. By Virtue of which I am entitled for protection under the SC/ST (Prevention of Atrocities) Act, 1989. Whereby, I am a permanent resident of K. Phaizawl P.S. Gannom Sapormeina District Kangpokpi

2. That, on the 5th May, 2023 at 3:00 PM, a huge contingent of armed Radical Meeitei/Meitei Mobs, Arambai Tenggol and Meeitei Leepun along with state Forces like Manipur Police Commando and Indian Reserve Battalion (IRB) attack our Village, in the process looted/Vandalized/burnt my house/properties.

3. That, the above said Criminals with their inhumane activities have made me loss enormous wealth estimated to be 26 Lakhs Only.

4. Fortunately, me and my Family narrowly escaped from these Criminals who even tried to kill us. Henceforth, we are taking refuge at T. Lanchah, Singngat.

I, therefore, request you to register an FIR/Zero FIR and bring justice.
