Subject: report on looting ,vandalism and burning of house, household items/assets.

Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I KIMNEILHING HAOKIP aged about 55 years, w/o (L) LUNNGAM HAOKIP belonging to the kuki community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under The SC/ST (prevention of Atrocities) Act, 1989. And that, I am a permanent resident of Kangchup Songlung P.O/P.S G.SPM, Kangpokpi District, Manipur.795
2. That, at about 1:00 am/pm on the 4 June,2023, a huge contingent of armed radical Meetei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun along with various state forces like Manipur Police Commando and Indian Reserve Battalion (IRB) attacked our villages and in the process, they have looted, vandalized and torched my house.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs 43,50000 (Rupees) Forty three lakhs fifty thousand only.
4. Fortunately , me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now taking refuge at BUNGMOL RELIEF CENTRE KANGPOKPI

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provision of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
