Subject:- Complain/Report on the crimes of criminal In Intimidation, unlawful looting, vandalism, arson attack and discrimination Scheduled Tribes.

## Dear Madam,

With reference to the above cited Subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Vaiphei Tribe, which recognized Tribe under the constitution of India.by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act, 1989. And, I am a permanent resident of Nakhujang Village. P.O. Lamsang, P.S. - G. Sapormeina and District - Kangpokpi, Manipur.

2. That, on the 2<sup>nd</sup> of June, 2023, at about 4:30 A.M., a huge contingent of armed radical Meitei/Meeteis suspected to be members of the Arambai Tenggol and Meitei Leepun attacked our Villages and in the

process, they have looted, vandalized and torched my house.

3. That, it may be reported here that the miscreants were shouting slogans like "KANGLEIPAK YAI PHARE", "KUKI HATLO", "HAO HATLO", etc while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the Police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

4. That,at the time of the attack we somehow managed to escape to save our lives under the compelling circumstances and thus could not take our belonging including important documents like Bank Passbook, Bank cheque book.etc. apart from other tangible materials. A list of our properties looted/destroyed/burnt is attached here under with its estimated costs. The total loss suffered is

estimated to be aboutRs.35,10,000/-( Rupeess Thirty five lakhs Ten thousand) only.

5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I am settled at a relief center at TD Block Lingsiphai, which is set up/organized by the young Vaiphei Association(YVA). And, thus I am filing the report lately today.

In the given circumstances. I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and Obliged.
