

Sir,

We, the Committee on Tribal Unity(CoTU) frontal organisation spearheading the emancipation of the Kuki-Zo Community in SADAR HILLS area from the clutches of the oppressive and partisan administration of the majoritarian Meitei community, would like to state the following points that on the wee hour 7-8 am on the 12th September 2023, three civilians were waylaid between Kharam Vaiphei and Ireng Naga village.

The three innocent and unarmed individuals were travelling in a white Gypsy tending their personel business and were shot dead in broad day light by suspected Meitei armed militant who were believe to use sophisticated assault rifles.

The deceased persons are:

- 1) **Pu Satneo Tuboi**, aged about **41 years** s/o Helsat Tuboi of K. Ponlen Village
- 2) **Pu Ngamminlun Lhouvum**, aged about **30 years** S/o Seineh Lhouvum of K. Ponlen Village.
- 3) **Pu Ngamminlun Kipgen**, aged about **31 years** S/o Thanggin Kipgen of Lhangkichoi village respectively.

Therefore, CoTU would like to request the concern authority to take cognizance of the incident and relevant case be registered upon.
