



Sir,

I the undersigned the Proprietor of M/s Mang Variety Store Licence No.: 013/Gr/003/2022 issued by Kangchup Twikun Village Authority and UDYAM Registration No. UDYAM-MN-05-0008185 at Kangchup Twikun Village, Kangpokpi District would like to report to your good office that on the fretful day i.e., the 5th June 2023 (Monday) around 10:30 a.m around One thousand Meitei Mob led by the Arambai Tenggol & Meitei Leepun under the guidance of the people/villagers of Singda-Kangdangband, Imphal West District were attacking our village i.e., Kangchup Twikun Village Kangpokpi District by using sophisticated weapons & bombs, shells etc. and when they dispersed the local people and as we (the villagers) were running for our life and safety and while our village was left for about 30 minutes for preparation of defence & retaliation. The intruders (the attacker) robbed and vandalised our houses, shops, establishments and burnt down around 6 houses of Kangchup Twikun Village but due to the timely intervention of local volunteers they could save the remaining houses/shops of our village from the intruders. My Poultry farm was totally looted and vandalised by the so called Meitei Mob/Arambai Tenngol/Meitei Leepun and villagers of Singda-Kadangband Imphal West.


