The intruders (the attacker) robbed and vandalised our houses and burnt down around 6 houses of Kangchup Twikun Village but due to the timely intervention of local volunteers they could save the remaining houses of our village from the intruders. My Poultry farm was totally looted and vandalised and half burnt by the so called Meitei Mob/Arambai Tenngol/Meitei Leepun etc.
