I the undersigned the Proprietor of M/s **MOMOI CHICKEN CENTRE** Licence No.: **SH-ADC 3331** issued by District Council Administration Sadar Hills Autonomous District Council and UDYAM Registration No. **UDYAM-MN-06-0001960** at Kanchup Twikun Village, Kangpokpi District would like to report to your good office that on the fateful day i.e., the 5<sup>th</sup> June 2023 (Monday) around 10:30 a.m around One thousand Meitei Mob led by the Arambai Tenggol & Meitei Leepun under the guidance of the people of Singda-Kangdangband, Imphal West District were attacking our village i.e., Kanchup Twikun Village Kangpokpi District by using sophisticated weapons & bombs, shells etc. and when they dispersed the local people and as we were running for our life and safety and while our village was left for about 30 minutes for preparation of defence & retaliation. The intruders (the attacker) robbed and vandalised our houses and burnt down some houses of Kanchup Twikun Village but due to the timely intervention of local volunteers they could save the remaining houses of our village from the intruders. My Shop was totally looted and vandalised and destroyed by the so called Meitei Mob/Arambai Tenggol/Meitei Leepun etc.


