Sir.

With due respect, I have the honour to report that on 4th May, 2023 at around 12 AM unknown Meitei miscreants suspected to be Arambai Tenggol holding deadly weapons after burning our neighbouring villages namely—Singda Kuki, Patjang, Songlung, Chingkhong, K Phaijol, K Moljol, Bethel Nakhojang etc. entered our village, i.e., Kotzim Village, Khangchup, looted and vandalized our household goods and properties. One Marshall Jeep bearing No.MN01L2338 along with one Pulsar Bike bearing No.MN01W6338 were also burnt down, Commandos and Meitei militants was also present among the violent mobs. Due to the fear of our lives being in danger, we fled from our village, leaving behind all our assets and home. The total costs of the looted household properties are estimated to be approximately Rs. 10,00,000/- (Rupees twenty lakhs).

The incident could not be reported in time due to insecurity of our lives and the volatile situation of the area.

I, therefore, request you to take necessary action against the perpetrators/culprits involved in commission of the crime.
