Needless to say we were hiding in the jungle/woods till 13.05.2023 as there was no security force for our protection. It is pertinent to mention that the Meitei militants were firing guns in the neighbouring village and were also surveilling the area with their drones.

I, therefore, request you to kindly register my complaint.
