



Sir,

With due respect and humble submission, I beg to state that on 5th, and 6th, of June 2023 at around 11:30 AM some unknown miscreants armed youth suspected to be Meitei youth Organisation, Arambai Tenggol, Meitei Leepun, Kangleipak Kanba Lup (KKL) and Meitei militant numbering about 1000 member carrying sophisticated like AK, SLR, forcefully entered my village Kangchup Twikun PO. Lamsang PS, Gamnom Sapormeina K. Geljang Sub Division, Kangpokpi District, Manipur. After looting all the properties the house was completely damaged.

The details of properties loss are as follows:

House damaged, Gas stove, Cylinder Gas Box, Computer Destop, Laptop, Vending Machine, Dining Table, Gold earring and necklace, Generator 25KV, Other Kitchen items, Bed (4), Almirah (4), Smart TV, Solar plate, Fridge, Washing machine, Battery, Sofa set, Kitchen almirah, water container (2000 ltr.x2), Bicycle, Rice (50 bags), Pig (4), Dog (3), Duck (7), and many other valuable item were also loss.

The total worth of the properties was estimated to about Rs.25,00,000/- (Twenty Five Lakhs)

I request you to kindly register the case and take necessary action according to law.


