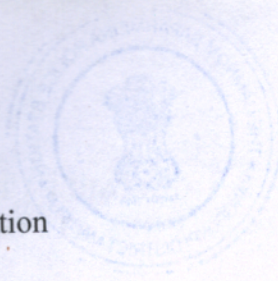

After attacking our village, the house was also looted.

The total worth of the properties was estimated to about Rs. 7,00,000 (Seven lakhs)

I request you to kindly register the case and take necessary action according to law.
