



Sir,

With due respect and humble submission, I beg to state that on the 5th and 6th of June 2023 at around 10:30 PM some unknown miscreants armed youth suspected to be People liberation army..(PLA) united national liberation front (UNLF) Kanglei Yaowon Kanna Lup (KYKL) and prepak cadres assisted by meeitei Youth organization Arambai Tenggol meeitei leepun and kangleipak kanba lup (KKL) numbering about 1000 member carrying sophisticated like AK Rifles, SLR forcefully entered my village Kangchup Twikun, PO Lamsang, PS Gamnom Sapormeina, K Geljang Sub Division, Kangpokpi District, Manipur.

After looting all the properties, the house was completely damaged.

The total worth of the properties was estimated to about Rs. 12,00,000 /- (Twelve Lakhs)

The details of properties lost are as follows:

House damaged, Gas stove, Cylinder (3), Other kitchen items, Bed (4), Almirah (2), Smart TV, Solar plate, fridge, washing machine, Battery, Sofa set, Kitchen Almirah, Water container (2000 L x2), Bicycle, Rice (20 bags), Pig (2), Dog (3), Duck (6) and many other valuable items were also lost.

I request you to kindly register the case and take necessary action according to law.


