With due respect and humble submission, I beg to state that on 03-05-2023 at around 9:30 pm, some unknown miscreants, armed youths suspected to be United National Liberation Front (UNLF), People Liberation Army (PLA), Kanglei Yaowon Lup (KKL) and PREEPAK candres assisted by Meetei Youth Organisation, Arambai Tenggol, Meetei Leepun and Kangleipak Kanba Lup (KKL) numbering about 1000 members carrying sophisticated Rifles forcefully entered Kangchup Twikun, Kangpokpi District, Manipur.

After attacking our village, the house was also looted.

The approximate value of lost properties is estimated to be about Rs. 90,00, 000/-(Ninety lakhs)
