Respected Sir,

1. the undersigned beg to report for your kind and necessary action

1. That, I and my family members are victims of the present unrest that occurred from 03/05/2023 onwards.
2. That, on 4-05-2023 at around 11.00 a.m./p.m. while I was at home along with my family members consisting of myself, my husband/wife, children and other family members, some unknown armed miscreants attacked my village. To save ourselves we fled and took shelter to a relief camp leaving everything behind.
3. That, on 20-06-2023 at around 9.50 a.m./p.m. when I returned home to look after my belongings. But all my household properties worth around 12,00,000 (apx) were found to be destroyed and looted by the unknown miscreants suspected to be Kuki militants.
4. That Delay of filing a F.I.R. is due to displacement and uncertainty of relief/place

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.
