After looting all the properties, the house was completely damaged.

The details of properties burned are as follows:

Residential house, properties of common Room, Kitchen materials, Electrical appliances, Bed room furniture, Bed, Almirah, jewelleries and many other valuable items were also lost.

The total worth of the properties was estimated to about Rs. 20,00,000/-(Rupees Twenty Lakhs)
