



Sir,

With due respect and humble submission, I beg to state that on 07-06-2023 at around 10:00 Am some unknown miscreants armed youth suspected to be Meitei youth Organization, Arambai Tenggol, Meeitei Leepun and Kangleipak Kanba Lup (KKL) and Meitei militants numbering about 1000 member carrying sophisticated like AK Rifles, SLR, forcefully entered my village K.Ponlen, PO Lamsang, PS Singda, Kangpokpi District, Manipur. After looting all the properties, the house was completely damaged.

The details of properties burned are as follows:

Residential house, properties of common Room, Kitchen materials, Electrical appliances, Bed room furniture, Bed, Almirah, jewelleries and many other valuable items were also lost.

The total worth of the properties was estimated to about Rs. 20,00,000/- (Rupees Twenty Lakhs)

I request you to kindly register the case and take necessary action according to law.
