I have the honour to state, on date 04/05/2023 at around 11:00 AM some unidentified groups suspected to be the members of Meitei Organisation such as Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tengol about 1500-2000 people, carrying sophisticated weapon. They forcefully entered our village Kangchup Patjang, PO Lamsang, PS Gamnom Saparmeina, Kangpokpi District, Manipur.

After looting all the movable properties, they vandalised and burnt down my residence and a poultry farm to ashes. The approximate value of properties destroyed estimate calculate at about Rs. /- 28,50,000 (Rupees Twenty-eight Lakhs and fifty thousand).

So, I therefore requested you to kindly register this case and take the necessary legal action against the culprits according to the law.
