They forcefully entered our village Kangchup Patjang, PO Lamsang, PS Gamnom Saparmeina, Kangpokpi District, Manipur.

After looting all the movable properties they vandalised and burnt down my Shop (Lendou adventure and Lendou Iron and Steel industry). The approximate value of properties destroyed estimate calculate at about Rs. 5,00,000/- (Rupees Five Lakhs).

So, I therefore requested you to kindly register this case and take the necessary legal action against the culprits according to the law.
