Sir,

Multiple inputs were received about the move of Mr. Ngamkhogin @ Hegin, the SS C-in-C of KNLA, in general area Sapermeina (Notified Area) on 20 feb. 2023. Based on the inputs, multiples columns of 4 Assam Rifles were launched.

The first column was launched at 1300 hours and reached general area Sapermeina (Notified area), District Kangpokpi at 1500 hours and established surveilance where SS C-in-C of KNLA Mr. Ngamkhogin @ SS Chairman Hegin was spotted and apprehended at 1510 hours. During on the spot verification/ interrogation the individual confirmed his identity and revealed that cadres of KNLA were currently present in general area Chanderkhong (Notified Area).

The first column thereafter moved south of general area Maphou Dam and linked up with the second column of COB Yaingangpokpi with strength of one officer, one JCO and 18 other rank and the column was guided by SS Chairman Ngamkhogin @ Hegin to general area TangkhulKhullen (Notified Area) Two stops were established on the likely escape routes and one column approached and searched the residence of KNLA cadre SS Private Sasang from where he was apprehended at 1820 hrs. Thereafter, SS Chairman Hegin contacted SS Private Thongkhohao @ Haopu of KNLA over the mobile phone and asked to meet with him. The column moved towards the location where SS Private Thongkhohao @ Haopu of KNLA and SS SergentAmungKhamrang @ Yarsho of NSCN (IM) were present. The cadres observed the approaching column and tried to fleee on an Activa two wheeler (Registraion No. MN 01 C 6734) but were chased down and apprehended at 1910 hours. Thereafter the column, guided by SS Chairman Hegin moved towards the house of SS Private Khailenmang of KNLA from where he was apprehended at 2109 hours.

The medical examination of the apprehended individual has been completed. You are requested to further investigate and take necessary legal action against them. The arrest and seizure Memos are attached.
