

On the 4th May 2023 at around 11 am, unknown miscreants belonging to Meitei community numbering more than 1000 people suspected to be members of Arambai Tengol, Meetei Leepun and other have attacked our village i,e Kangchup Patzang Village under Kangchup Geljang Subdivision by holding deadly weapons including automatic rifles and Bomb. The miscreants have ransacked and burnt down my house and all properties like furniture, kitchen items, clothing, barn, important documents, grains, rice, domesticated animals and other properties inside the house. The estimated value of properties lost, ransacked and burnt down by the miscreants is estimated to be about Rs. 50,00,000 (fifty-lakhs)/- only.

I therefore, request you to kindly take necessary action in this regard for which I shall remain ever thankful to you.
