Sir,

With due respect and humble submission, I beg to state that on 5-05-2023 at around 8:00 AM some miscreants from the Meitei community, armed youths suspected to be meitei Youth organizations like Arambai Tenggol, meeitei leepun and Kangleipak Kanba Lup (KKL) numbering about 1000 member carrying sophisticated automatic weapons forcefully entered my village; Singda Kuki village, P.O. Lamshang, P.S- Gamnom Sapormeina, Kangchup Geljang Sub-Division, Kangpokpi District, Manipur. After looting all the properties, the house was also burnt down to ashes.

The total worth of the properties lost was estimated to about Rs. 51,50,000 (Rupees Fifty one Lakhs and Fifty thousand)

I request you to kindly register the case and take necessary action according to law.


