Sir,

With due respect and humble submission, I beg to state that on 5-05-2023 at around 8:00 AM some miscreants from the Meitei community, armed youths suspected to be meitei Youth organizations like Arambai Tenggol, meeitei leepun and Kangleipak Kanba Lup (KKL) numbering about 1000 member carrying sophisticated automatic weapons forcefully entered my village; Singda Kuki village, P.O. Lamshang, P.S- Gamnom Sapormeina, Kangchup Geljang Sub-Division, Kangpokpi District, Manipur. After looting all the houses and turning to village to ashes, even the Church was burnt.
