With due respect and humble submission, I beg to state that on 5-05-2023 at around 8:00 AM some unknown miscreants armed youth suspected to be meeitei Youth organization Arambai Tenggol meeitei leepun and kangleipak kanba lup (KKL) and Meitei militants numbering about 1000 member carrying sophisticated like AK Rifles, SLR forcefully entered my village Singda Kuki village, P.O. Lamshang, P.S-Gamnom Sapormeina, Kangchup Geljang Sub-Division, Kangpokpi District, Manipur.

After looting all the houses and turning to village to ashes, even the Club office was burnt.

The total worth of the properties lost was estimated to about Rs 59,00,000 (Fifty nine Lakhs)
