Sir,

With due respect and humble submission, I would like to state that my village Singda Kuki Village, PO. Lamshang, P.S Gamnom Sapormeina, Saitu Gamphazol Sub District, Kangpokpi District was attacked by unknown miscreants with armed weapons on the night of 5th May 2023, The unknown miscreants suspected to be United National Liberation Front (UNLF), Kangleipak kanba Lup (KKL), KYKL, people Liberation Army (PLA), Arambai Tanggol, Meeitei Leepun carrying weapons looted our property and destroyed those they did not take. They also burnt the house to ashes after looting and destroying everything. Below mentioned are the estimate of the property looted, destroyed and burnt as a result

- 1) Residential House – Rs. 20,00,000
 - 2) Furniture (Almirah, Bed, Sofa set, etc) – Rs. 3,50,000
 - 3) Electronics (TV, Desktop, Laptop, Printer, etc) – Rs. 3,00,000
 - 4) Kitchen Utensils (Electric cooker, Water Filter, etc) – Rs. 1,00,000
 - 5) Gold Ornaments (Necklace, earring, etc) – Rs. 2,00,000
 - 6) Traditional Shawls – Rs 4,00,000
- Total estimated cost – 32,51,000 (Thirty-Two Lakhs fifty-One Thousand)


The above mentioned assets have all been either looted, destroyed or stolen. I request you to kindly register my case and take necessary action to the law.
