

I have the honour to state that, On 2nd June 2023 at around 5 P.m the Meitei community Arambai Tengol, Meitei Leepun and Meitei Militant carrying a sophisticated weapons attack our village i.e Nakhujang Village, Kangchup Geljang Sub – division Kangpokpi District. They robbed, demolished and burnt down my house along with the properties and important documents etc, The details are as follows

Total = 24,75,000/-

The total amount of burnt and robbed and destroyed properties are estimated at Rs. 24,75,000/- (twenty four Seventy five thousand) only. The incident could not be reported immediately, due to insecurity and volatile situation of the area.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime, Thanking You Sir.
