Sir,

With due respect, I have the honour to report the following few lines that, I am the devotee cum owner of Mahadeva temple located at the lower portion of Ingourok Mahadeva worship place. The worship place is look after by my forefathers since last 100 years back which is under the control of Kuki arms militants since the beginning of the current ethnic violence in the State i.e starting from 3<sup>rd</sup> May, 2023. Due to threatening of life by unknown armed miscreants suspected to be Kuki armed militants, I could't visit at my worship place till date. The upper side Ingourok Mahadeva worship temple had been burnt down on 5<sup>th</sup> May, 2023.

However on 11<sup>th</sup> September, 2023 it comes to light that, The said worship temple including structure of god Mahadeva was totally dismantle by using excavator probably in the month of June, 2023 by unknown persons suspected to be Kuki armed Militants. Regarding the matter, I couldn't report to the concerned police station i.e Gangnam Sapermeina Police Station due to the present ethnic violence in the State.

It is, therefore, requested you to kindly take up necessary legal action.
