





With due respect, I have the honour to report the following few lines that, I have staying at Motbung Meitei Leikai, Kangpokpi District. Due to the ongoing communal crisis between two communities. On 03/05/2023, I along with my whole family members have come out from the house and taking shelter at Kanto Sabal Awang Leikai Relief camp, IW district by keeping under locked and key. On 04/08/2023 at 2:30 pm, it comes to light that, suspected to be Kuki arms militant and Kuki rioters had trespass my house and torched by suspected to be Kuki militants and Kuki rioters. The approximate value of the properties that were burn down is about Rs. 10,00000/- (Rupees Ten Lakhs only)

Regarding the matter, I couldn't report to the concern police station i.e, Gamnom Sapermeina PS till date due to the present situation in the State. Hence I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
