The approximate value of the properties that were burn down is about Rs. 10,00000/-(Rupees Ten Lakhs only)

Regarding the matter, I couldn't report to the concern police station i,e, Gamnom Sapermeina PS till date due to the present situation in the State. Hence I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
