With reference to the above cited subject, I have the honour to report to you as below:

- That, I, Ngamboi Sitlhou age 21 h/o S. Lhaimonkim Vaiphei belong to the kuki Community, a Schedule Tribe recognized under the constitution of India. By virtue of which I am entitled for protection under the SC/ST (prevention of Atrocities) Act, 1989, whereby, I am a permanent resident of Singda Kuki Village, P.O/P.S - Sapormeina, Kangpokpi District.
- That, on 5th May 2023 at 3:00 am, a huge contingent of armed Radical Meitei/Meitei Mobs Arambai Tengol and Meitei Leepun along with State force Like Manipur Police Commando and Indian Reserve Battalion (IRB) Attacked our village, and in the process looted/vandalized/burnt my house/properties.
- 3. That, the above said criminals with their in humane activities have grave caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs. 36 lakhs only.
- Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us Henceforth, we are taking refuge at Mata - Dam IFCD Quarter, Churachandpur District.

Due to the present law and order situation, I could not submit FIR in time.

I therefore, request you to register an FIR/Zero FIR and bring justice.
