



With due respect, I the undersigned have the honor to report that my heavy machinery was hired by LECKON INFRASTRUCTURE PVT.LTD. But due to sudden outbreak of the crisis starting from 03/05/2023 and has been continuing till now, our work area: i.e Keithelmanbi of Kangpokpi District, Manipur was attacked by mob and mass destruction of properties took place. Luckily our workers, drivers and official staff of our project were all shifted to safety area. One JCB backhoe was left in front of Saparmeina police station thinking it was safe place to keep.


