

I am to bring to your kind notice that I am a Scheduled Tribe (Kuki – Zo) and a resident of Kharam Vaiphei Village, Kangpokpi District.

That, On the 10<sup>th</sup> May, 2023 at 1:30 Pm my above said residence “**Owned**/rented” was attacked, destroyed, looted and burned by Group of Meetei/Meiteis radicals.

These criminals broke/open my gate(s), destroyed and looted every property from my residence and premises worth rupees 18,82,100/- (Approx.) and they burnt down all the remainings.

While Carrying out their said criminals activities; the said Meitei radical groups were shouting anti –tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an **FIR/ZERO FIR** under relevant sections of Law.
