These criminals broke/open my gate(s), destroyed and looted every property from my residence and premises worth rupees 18,82,100/- (Approx.) and they burnt down all the remainings.

While Carrying out their said criminals activities; the said Meitei radical groups were shouting anti –tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/ZERO FIR under relevant sections of Law.
