



With due respect, I have the honour to state the following few lines that, I am a resident of Luwangshangbam Mayai Leikai and I along with my family members staying at the rented house of one Partiman Blon located at Leimakhong Bazar Kangpokpi District, since last 10 years back. On 04/05/2023 at around 11:10 am, I along with my whole family had fled away from my rented home after proper locked and key due to fear & safety of our life and returned back at my home located at Luwangshangbam Mayai Leikai. On 03/09/2023, it comes to light that, suspected to be Kuki arms militant and Kuki rioters had trespass my rented house and looted much of my properties. The approximate value of the properties that were looted is about Rs. 9.00.000/- (Rupees Nine Lakhs) approximately.

Regarding the matter, I couldn't report to the concern police station i.e, Gamnom Sapermeina PS till date due to the present situation in the State. Hence I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
