



With due respect, I have the honour to report the following few lines that, I along with my staff staying at the rented house of one Soratsati Karki located at Leimakhong Bazar Kangpokpi District, PS: Gannom Sapermeina Police Station since last 20 years back. However on 3rd May, 2023 at around 7:30 pm, large number of unknown persons suspected armed Kuki militants who stormed Meitei/Meetei inhabited areas. The said unknown suspected to be Kuki arms militants had trespass my Mobile shop cum repairing center and vandalized and looted many valuable properties after breaking door. The approximate value that were looted/vandalized of my property is about Rs. 15,00,000/-(Rupees Fifteen Lakh)

Regarding the matters, I couldn't report to the concern Police station i.e, Gannom Sapermeina PS till date due to the present situation in the State.

In this connection, I humbly request you to kindly initiate and take up necessary legal action against the above mentioned culprits.
