I am to bring to your kind notice that I am a Scheduled Tribe (kuki/zo) and a resident of
L. Phaijang Village

That, on the 4th May, 2023 at 05:00 Am my above said residence “**Owned/rented**” was
attacked, destroyed, looted and burned by a Group of Meitei/Meiteis radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property from my
residence and premises worth Rupees 90,000/- (approx.) and they burnt down all the
remainings.

While Carrying out their said criminals activities, the said Meitei radical groups were shouting
anti-tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an
FIR/Zero FIR under relevant sections of Law.
