

That, on the 4<sup>th</sup> May, 2023 at 5:00 Am my above said residence “Owned/rented” was attacked, destroyed, looted and burned by a Group of Meetei/Meiteis radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property from my residence and premises worth Rupees 700000 ( approx.) and they burnt down all the remainings.

While Carrying out their said criminals activities, the said Meitei radical groups were shouting anti-tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of Law.
