

Subject:- Report.

Sir,

With due respect, I have the honour to state that, I am resided at Saitu Sapermeina Meitei leikai which is under the control of Kuki arms militants since the beginning of the current ethnic violence in the State i.e. starting from 3rd May, 2023. Due to threatening of life by unknown armed miscreants suspected to be Kuki armed militants, on the same day i.e. 3rd May, 2023, I along with my whole family members had escaped from my house and taking shelter at my wife paternal house i.e. Maharabi village till date.

However, on 6th May, 2023, it comes to light that some unknown persons suspected to be Kuki armed militants had trespass my house in between 3rd May, 2023 to 4th May, 2023 and burnt down my house as well as looted many valuable properties i.e. Furniture items, kitchen items, clothing items, utensil items, electronics items etc. The approximate value of the burnt down & vandalized properties is estimated about Rs 7 Lakh (Rupees Seven Lakh) approximately.

Regarding the matter, I couldn't able to report to the concerned police Station i.e. Gamnom Sapermeina Police Station due to present ethnic violence in the State as well as lack of legal knowledge.
