

Sir,

I am to bring to your notice that I am a Scheduled Tribe(Kuki/Zo) and a resident of Nakhujang, Kangchup Kangpokpi Dist.

That, on the 29th May,2023 at Nakhujang my above said residence "Owned/Rented" was attacked, destroyed, looted and burned by a Group of Meitei/Meiteis radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property from my residence and premises worth Rupees 10,21,000/- (Approx.) and they burnt down all the remainings.

While carrying out their said criminals activities; the said Meitei radical groups were shouting anti-tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of Law.
