

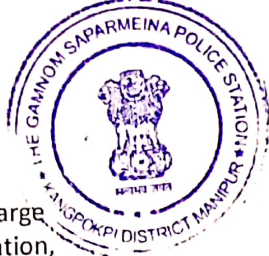

With reference to the above cited Subject, I have the honour to report to your good Office as follows:

That, I **Ginlalle Vaiphei** aged about 41 Yrs. S/o (L)**Siakhholal Vaiphei** belonging to the Vaiphei Tribe/Community, a schedule Tribe recognized under the constitution of India. by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**,

That I would like to inform and register a cognizable Offence carried against me and my family at our resident located at **Kharam Vaiphei, Kangpokpi District PO/PS Kangchup**.

That, on the **15th of July, 2023**, at around **10:30 AM** huge contingent of armed radical Meitei/Meeteis suspected to be members of the Arambai Tenggol and Meitei Leepun attacked our deserted locality and in the process vandalized and looted our along with house along with all the properties.

That, it may be reported here that above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated (approx..) to be **Rs 2700000 (twenty seven Lakhs)** only.

Fortunately, me and my family managed to escape from the criminals who even try to kill and now currently taking refuge at **Mata Relief Camp Churachandpur District Manipur**.

I am filing this report lately since I have been at different places for safety. Now, since I am able to settle myself at the above mentioned address, I am in a position to file a report today. Hence, prayed that my report be accepted.

In the given circumstances, I humbly pray you to kindly register a **FIR/ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and Obligated.
