





I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of Kharam Vaiphei Kangpokpi Dist.

That on the 04 May, 2023 at 1:00 Pm my above said residence (Owned/Rented) was attacked, destroyed, looted and burned by a Group of Meetei/Meiteis radicals.

These criminals broke/open my gates(s) destroyed and looted every valuable property from my residence and premises worth Rupees 2,025,000/- (Approx.) and they burnt down all the remainings.

While carrying out their said criminal activities; the said Meitei radical groups were shouting anti-tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an **FIR/Zero FIR** under relevant sections of Law.

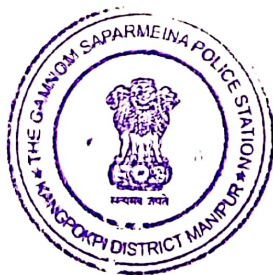
