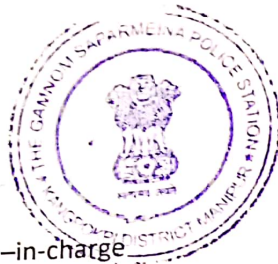



That on the 5 May 2023 at 5:00 Pm my above said residence (Owned/Rented) was attacked, Destroyed and looted and burned by a group of Meitei radicals.

These criminals broke/open my gates(s) destroyed and looted every valuable property from my "Owned/Rental" House, and premiss worth Rupees 2,50,000/- (Approx) and they burnt down all the remaining things.

while carrying out their above said Criminal activities, the said Meitei radical groups were shouting anti-Tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of Law.

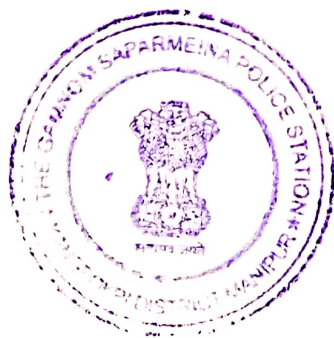
