

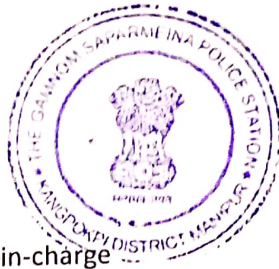

I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of Kharam Vaiphei Village.

That on the 4th May 2023 at 10:00 Pm my above said residence (Owned/Rented) was attacked, Destroyed and looted and burned by a group of Meitei radicals.

These criminals broke/open my gates(s) destroyed and looted every valuable property from my residence and premises worth Rupees 4,00,000/- (Approx) and they burnt down all the remainings.

While carrying out their said Criminal activities, the said Meitei radical groups were shouting anti-tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an **FIR/Zero FIR** under relevant sections of Law.
