



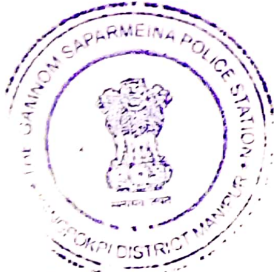

That on the 11th May 2023 at 10:00 am my above said residence (Owned/Rented) was attacked, destroyed, looted and burned by a group of Meetei/Meiteis radicals.

These criminals broke/open my gates(s), destroyed and looted every valuable property from my residence and premises worth Rupees 6 Lacs (Approx) and they burnt down all the remaining.

While carrying out their above said Criminal activities; the said Meitei radical groups were shouting anti-tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of Law.
