

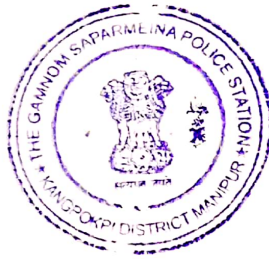

These criminals broke/open my gates(s) destroyed and looted every valuable property from my "Owned/Rental" House,and premiss worth Rupees 42,55,000 (Approx) and they burnt down all the remaining things.

while carrying out their above said Criminal activities,the said Meitei radical groups were shouting anti-Tribal slogans like.

I,therefore,request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of Law.
