I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of Kharam Vaiphei Village.

That on the 05 May 2023 at 10:00 Pm my above said residence (Owned/Rented) was attacked, destroyed and looted and burned by a Group of Meitei/Meiteis radicals.

These criminals broke/open my gates(s), destroyed and looted every valuable property from my residence and premises worth Rupees 5 Lakh (Approx.) and they burnt down all the remainings.

While carrying out their above said criminal activities; the said Meitei radical groups were shouting anti-Tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of Law.
